Ono Announces Status of Acquisition of Own Shares

(Acquisition of own shares under the Articles of Incorporation pursuant to the provision of Paragraph 2, Article 165 of the Companies Act)

Osaka, Japan, January 5, 2024 - Ono Pharmaceutical Co., Ltd. (President and CEO, Gyo Sagara; “the Company”) today announced that it has acquired its own shares pursuant to the provision of Article 156 of the Companies Act, applied by replacing terms pursuant to the provision of Paragraph 3, Article 165 of the same Act.
